





**THE COMPANIES ACT 2013**

**MEMORANDUM OF ASSOCIATION<sup>1</sup>**

**IRIS BUSINESS SERVICES LIMITED**

- I. The name of the Company is “**IRIS BUSINESS SERVICES LIMITED**”.
- II. The registered office of the Company will be situated in the State of Maharashtra.
- III. The objects for which the Company is established are:

**(A) THE OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:<sup>2</sup>**

- 1) To establish the knowledge infrastructure so needed to support new and existing enterprise; to leverage the emerging technology (as associated with the internet) for establishing, selling and managing business information and knowledge relevant to the commercial environment and needs of India; to sell business information; to develop software solutions by integrating public domain information with private domain to create knowledge networks within corporations; to serve as information incubators for e-commerce platforms for groups of companies within industry segments and for individual consultants scattered across India and overseas.

**(B) MATTERS WHICH ARE NECESSARY FOR FURTHERANCE OF THE OBJECTS SPECIFIED IN CLAUSE III(A) ARE:<sup>3 4</sup>**

- 2) To encourage, assist, set up and promote internet based Electronic Commerce transactions and web-based online transactions by individuals, corporates and community at large and for such purpose to act as an agents, dealers, distributors, franchises, consultants, managers, software and systems designers and developers and enter into set up distribution channels and network, appoint agents, dealers, distributors, franchises, suppliers of goods and services, and to set up facilities to educate, advertise, promote, market and encourage e-Commerce and web-based services.
- 3) To set up workstations at various locations, provide internet connectivity, web browsing facility, web-based services and to carry out e-Commerce transactions for the benefit of the community and for that purpose to compile the database of the community and to

provide consultancy and management of the centres, computer hardwares, softwares, services, servers, communication lines, internet connectivity, manpower, information technology related education, entertainment and training centres and generally, to buy, sell, export, import, hire, improve, alter, assemble, indent and deal in information technology related products and services including hardwares, softwares, peripherals, accessories, and telecommunication products, connectivity and services.

- 4) To provide consultancy and management of information technology related products and services and to act as projects consultants, manpower consultants, e-Commerce consultants, management consultants, internet service providers and consultants and to organise and sponsor seminars, workshops, conferences to promote the concept of e-Commerce and web based services.
- 5) To secure, promote, organise, manage or enter into collaboration agreement in all its branches with any person, firm, company, corporation, authority, body or other entity in India or abroad to acquire technical know-how, buy back arrangement, procurement of capital goods, financial assistance, training and development or for any other purpose whatsoever and subject to law in force pay such commission, fees royalty or other charges as may be agreed from time to time.
- 6) To buy, and otherwise deal in all kinds of plant, machinery, apparatus, tools, necessary or convenient for carrying on any of the business or processes of the Company.
- 7) To appoint agent for purchasing, selling and distributing the products by the Company or any of them in any part of the world.
- 8) To take part in the promotion, formation, management, supervision or control of the business or operations of any company, associations or undertaking and for that purpose to act as administrators, managers, receivers in any other capacity and to appoint to remunerate any directors, administrators, managers or accountants or other experts or agents.
- 9) To pay out of the company's funds the costs and expenses incurred in connection with all matters, preliminary and incidental, to the formation, promotion and incorporation of the company and the costs and expenses incurred in connection with all matters preliminary and incidental to the formation and incorporation of any company which may be promoted.
- 10) To obtain any rights, concessions, privileges, permissions and the like, periodically or otherwise, which may consider conducive to the interests or the business of the Company from any Government, States, Municipalities, Local Boards, Museums, Libraries, or any authorities supreme, or otherwise and to carry out, use, exercise and comply with such rights, privileges, concessions, permissions and arrangements.
- 11) To carry on the business of doing the job-works for others, giving the job work to others or to accept or give any work on contract basis from time to time and upon such terms and conditions as may be thought expedient for the furtherance of the main objects.

- 12) To enter into contracts, agreements and arrangements with any other company, firm or person for the carrying out by such other company, firm or person on behalf of the Company, of the objects for which the Company is formed.
- 13) To employ experts to investigate and examine into the condition, prospect, value, character and circumstances of business, concerns and undertakings and generally of any assets, properties or rights.
- 14) To carry on the business or branch of business which this Company is authorised to carry on by means, or through the agency of any subsidiary company or companies and to enter into any arrangement with such subsidiary company for taking the profit so carried on, or for financing any such subsidiary company or guaranteeing its liabilities or to make any other arrangement which, may seem desirable with reference to business or branch so carried on including power at any time either temporarily or to close any such branch or business.
- 15) To appoint agents for purchasing, selling and distributing the products of the Company or any of them in any part of the world.
- 16) To appoint and remunerate engineers, contractors, managers, brokers, canvassers, agents and other persons and to establish and maintain agencies or branches in any part of the world and otherwise for the purpose of the Company and to discharge and to discontinue the same.
- 17) To negotiate and enter into agreements and contracts with foreign or other companies, firm and individuals for agency, distributorship, technical assistance, know-how and collaboration in the setting up and operation of the undertakings, marketing, importing and exporting of the equipments, plants, products, apparatuses and other articles and things or any of them for all or any of the business of the Company and to pay to such company, firm or individual any fee, royalty, shares, bonds, remuneration and otherwise compensate them in any other manner for the services rendered by them.
- 18) To insure the whole or any part of the property of the Company either fully or partly, to protect and indemnify the Company from liability or loss in any respect either fully or partly, and also to protect and indemnify any part of portion thereof, either on mutual principle or otherwise.
- 19) To nominate Directors or Managers of any subsidiary company or any other company in which this Company is or may be interested.
- 20) To take part in the supervision and control of the business or operations of any company or undertaking having similar objects.
- 21) For the purpose mentioned in the preceding clause, to appoint and remunerate any directors, trustees, accountants or other experts or agents.
- 22) To exercise all or any of its corporate powers rights and privileges and to conduct its business, in all or any of its branches in the Union of India and in any or all states, territories, possessions, colonies and dependencies thereof and in any or all foreign



countries, and for this purpose to have discontinued such number of offices and agencies therein as may be convenient.

- 23) To carry out in any part of the world all or any part of the Company's objects as principal, agent, factor, trustee, contractor, either alone or in conjunction with any other person, firm, association, corporate body, municipality, province, state or government or colony dependency thereof.
- 24) To construct, improve, maintain, develop, work, manage, carry out or any buildings, works or any roads, railway, branches, or sidings, bridges, wells, water-courses, wharves, warehouses, electric works, shops, stores and other buildings for housing employees of the Company and conveniences which may seem calculated directly or indirectly to advance the Company's interests and to contribute to subsidise or otherwise assist or take part in the construction, improvement, maintenance, development, working, management, carrying out thereof.
- 25) To let on lease or on hire-purchase system or to lend or otherwise dispose of any property belonging to the Company, and to finance the purchase of any article or articles, whether made by the Company or not, by way of loans or by the purchase of any such article or articles, and the letting thereof on the hire-purchase system or otherwise howsoever.
- 26) To sell, lease, grant licenses, easements and other rights over and in any other manner deal with or dispose of the undertaking property, assets, rights and effects of the company or any part thereof, for such consideration as the Company may think fit, and in particular, for shares, debentures and/or securities of any other company.
- 27) To acquire and undertake the whole or any part of the business, property, and liabilities of any person, firm or Company carrying on or proposing to carry on business which the Company is authorised to carry on, or possessed of property suitable for the purpose of this Company, which can be carried on in conjunction therewith.
- 28) To amalgamate with any other company or companies having similar objects to enter into any partnership or partially amalgamate with or acquire interest in the business of any other company, or enter into any arrangement for sharing profits, or for co-operation or for mutual assistance, with any such person, firm or company.
- 29) To enter any arrangement for sharing profits or losses, or for any union of interest, joint-venture, reciprocal, concession carrying on, or engaged in or about to carry on or engage in or being authorised to carry on.
- 30) To enter into any arrangement with any Government or authority, supreme, municipal, local or otherwise or any person or company that may seem conducive to the Company's objects or any of them and to obtain from any such Government, authority, person or company any rights, privileges, characters, contacts, licenses and concessions which the Company may think fit and desirable to obtain and to carry out, exercise and comply therewith.
- 31) To apply for, promote and obtain any Act, charter, privilege, concession, license, authorization, if any, Government, State or municipal, provisional order or license of any authority for enabling the Company to carry out any of its objects into effect or for

extending any power of company, or for effecting any modification of the Company's constitution, or for any other purpose which may seem expedient to oppose any proceedings or application which may seem calculated, directly or indirectly, to prejudice the Company's interest.

- 32) To apply for, purchase, or otherwise or otherwise acquire, and protect and renew, in any part of the world any patents, rights, brevets, invention, trademarks, logos, designs, licenses, concessions, and the like conferring any exclusive or non-exclusive or limited rights to their use, or any secret or other information as to any invention which may seem capable of being used for any of the purposes of the Company and to use, exercise, develop or grant licenses in respect of or otherwise turn to account the property rights; or information so acquired, and to extend money in experimenting upon, testing or improving any such patents, inventions or rights.
- 33) To establish, provide, maintain and conduct, or otherwise subsidise research laboratories and experimental workshops for scientific and technical researches, experiments and to undertake and carry on, with all scientific and technical researches, both scientific and technical, investigation and invention by providing subsidizing endowing or assisting laboratories, workshops, libraries, lectures, meetings and conferences and by providing for the remuneration of scientific or technical professors or teachers and by providing for the award of exhibitions, scholarships, prizes and grants to students or otherwise and generally to encourage, promote and reward studies, researched, investigations, tests and inventions of any kind that may be considered likely to assist any of the business which the Company is authorised to carry on.
- 34) To make donations to such persons or institutions and in such case either of cash or any other assets as may be thought fit directly or indirectly conducive to any of the Company's objects or otherwise expedient and, in particular, or remunerate any person or corporation introducing business to this Company, and also to subscribe contribute, or otherwise assist or guarantee money for charitable, scientific, religious or benevolent, national, public, cultural, educational or other institutional, objects or for any exhibition or for any public, general or other objects and to establish and support or aid in the establishments and support of associations, institutions, funds, trusts and conveniences for the benefit of the employee or employees (including Directors) of the Company or its predecessors in business or the dependents, of such persons and, in particular, friendly or other benefit societies and to grant pensions, allowances, gratuities and bonuses, either by way of annual payments or lumpsum, and to make payments to wards insurance and to form and contribute to provident benefit funds and other welfare funds of or for such sums.
- 35) To refer, or agree to refer, any claim, demand, dispute, or any other question, by against the company, or in which the Company is interested, concerned, and whether between the Company and the member or members or his or their representatives, or between the company and third parties to arbitration in India or at any place outside India and to observe and perform and to do all acts, deeds, matters and things to carry out or enforce the award.
- 36) To pay out of the funds of the Company all expenses which the Company may lawfully pay with respect to the promotion, formation and registration of the Company or the issue of its capital, including brokerage and commission for obtaining applications for or taking,

placing or underwriting or procuring the underwriting of shares, debentures or other securities of the Company.

- 37) To pay all preliminary expenses of any company promoted by the Company or any company in which the company is, or may contemplate being interested; including in such preliminary expenses all or any part of the costs and expenses of owners of any business or property acquired by the Company.
- 38) To pay for any rights, licenses, patents, concessions or property acquired by the Company and to remunerate and person or company services rendered or to be rendered in placing of shares in the Company's capital or any debentures, debenture stock, or other securities of the Company, or in or about the formation or promotion of the Company, or the acquisition of property by the Company, or the conduct of its business whether by cash payment or by the allotment of shares, debentures, or other securities of the Company, credited as paid up in full or in part or otherwise.
- 39) To remunerate the Directors, Officers and servants of the company and others out of or in proportion to the returns or profits of the Company or otherwise as the Company may think fit, to formulate and carry into effect any scheme for sharing the profits of the Company with employees of the Company or any of them to grant pensions, gratuities, provident fund and other benefits to employees or ex-employee or the relatives.
- 40) To adopt such means of making known the business of the Company as may seem expedient, and in particular, by advertising in the press, souvenirs, radio, cinema, television, by circulars, by purchase and exhibition or words of art or interest, by publication of books and periodicals, and by granting prizes rewards and donations.
- 41) To lend advance money or to give credit to such persons or company as and on such terms as may seem expedient and, in particular, to customers and other having dealings with the Company and to guarantee the performance of any contract or obligation and the payment of money of or by any such persons or companies and generally to give guarantees and indemnities; but not to do Banking business as defined in Banking Regulation Act, 1949.
- 42) To invest and deal with the moneys of the Company not immediately required in such manner as may from time to time be determined, subject to the Company Act, 1956.
- 43) To receive money on deposit or loan and borrow or raise money in such manner as the Company shall think fit, and in particular, by the issue of bonds, debentures, or debenture stock (perpetual or otherwise) and to secure the payment of any money borrowed, raised crowing by mortgage, charge or lien upon all or any of the property or assets of the Company (both present and future), including its uncalled capital, and also by a similar mortgage, charge or lien to secure and guarantee the performance by the Company or any other person or company of any obligations undertaken by the Company as the case may be. The acceptance of deposits shall be subject to Section 58-A of the Companies Act, 1956 and the rules framed there under and the directions of Reserve Bank of India.
- 44) To undertake and execute any trusts, the undertaking of which may seem to the Company desirable and either gratuitous or otherwise.

- 45) To undertake, carry out, promote, contribute to or sponsor any programme of rural health or development including any programme for mass immunization or for promoting the health, social and economic, welfare, or the public in any rural area, to assist in the execution and promotion of any such programmes either directly or through the agency of any persons or in any other manner and to incur expenditure on any such programme rural health or development with power to the Directors to transfer, or with consideration, or divert the ownership of any property of the Company to or in favour of any person or persons including any public or local body or authority. Central or State Government, and public institutions or any trust fund as the Directors may in their sole, and absolute discretion decide.
- 46) To draw, make, accept, endorse, discount, execute and issue bills of lading, warrants, debentures, bonds, and other negotiable or transferable instruments or securities, subject to the Banking Regulations Act, 1949.
- 47) To sell, improve, manage, develop, mortgage, dispose of, turn to account or otherwise deal with all or part or the property of the Company and rights of the Company for the time being.
- 48) Subject to the provisions of the Companies Act, 1956, in the event of winding up to distribute among the members in specie any property of the Company, or any proceeds of sale or disposal of any property of the Company.
